
Pre-qualification applications are invited from the interested parties / companies / enterprises. The bidding documents shall be issued only to the pre-qualified firms. For prequalification, the interested Parties / Companies / Enterprises are requested to provide complete information duly supported with authenticated documents for the evaluation purpose as per PPRR Rules 2004.

The pre-qualification applications shall be received in sealed envelopes and to be submitted in the office of GM (Punjab-North), Shahpur Interchange, Tohkar Niaz Baig, Multan Road Lahore upto 1st June, 2010 during working hours. The firms stand as pre-qualified, shall be informed to purchase bidding documents from the office of undersigned on payment of Rs.2000/- in shape of Payorder/demand draft in favour of General Manager (Pb-N) NHA, Lahore. Terms & Conditions of the pre-qualification shall be as under:

- Name and Postal address of the Firm / Company alongwith partnership / Power of Attorney and copy of CNIC.
- Valid Pakistan Engineering Council (Operators') Certificate.
- The Company / Enterprise shall provide and furnish certificate from Registered Security Company.
- Financial Certificate, showing Bank Statement of transactions for the last one year.
- Experience of previously providing similar services to various organizations (if any).
- Details of available staff and organization chart of the firm.
- Any other details which are deem necessary to evaluate capability of the firm.

Sub-sequent to pre-qualification, Notice Inviting Tenders / Bids shall be issued owing to following terms and conditions:

- The contract would be initially for three years extendable by one year with mutual consent.
- Each bid shall be accomplished with Earnest Money in the shape of Demand Draft / Pay Order amounting to Rs.100,000/- in the name of GM (Punjab-North), Shahpur Interchange, Tohkar Niaz Baig, Multan Road Lahore for each section.
- The successful bidder shall have to provide Bank Guarantee from Scheduled Bank of Rs.1,000,000/- during the currency of contract in the name of National Highway Authority, Road Maintenance Account.
- The successful bidder will be responsible to accept the terms and conditions or any revision made by NHA.
- Competent Authority reserves the right to accept or reject any or all the bids without assigning any reason thereof.
