1. With reference to the RFP Notice referred above, all prospective Consultants/Individuals are informed that the referred procurement process has been **ANNULLED** in accordance with PPRA Rule-33. All Consultants/ Individuals who participated in the said bidding are here by requested to collect their sealed Financial Proposals through their authorized representative, preferably before **June 30th, 2021**.
2. NHA intends to hire/ engage the services of an eligible individual consultant to carry out external monitoring for implementation of Land Acquisition and Resettlement Plans for Tranche-II of MFF: CAREC Corridor Development Investment Program.
3. Proposals based on Single Stage Two Envelop procedure are invited from eligible Individual Consultants (i) having valid PEC registration in relevant field with relevant experience in similar conditions and appropriate skills for the assignment as mentioned in Request for Proposals (RFP); (ii) who are registered with Income Tax and Sales Tax Departments. (iii) who are on Active Tax Payers list of the Federal Board of Revenue. Interested Individual Consultants may download the RFP document(s) from NHA website i.e. (www.nha.gov.pk) free of cost or the same can be purchased from the office of General Manager (P&CA), NHA-HQ, Islamabad during working hours and working days on written request of consultant/Individual letter head accompanied with pay order/demand draft amounting to Rs.1,000/- (non-refundable) in favor of National Highway Authority.
4. Pre-Proposal Conference will be held on **30th June, 2021 at 1130 hours** in the P&CA Conference Room, NHA-HQ, Islamabad. Due to COVID-19, only one authorized representative will attend the pre-proposal meeting as well as proposal opening event.
5. The Proposals complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on or before **13th July, 2021 at 1130 hours** in NHA Auditorium, 27-Mauve Area, G-9/1, Islamabad and be clearly marked **“External Monitoring for Implementation of Land Acquisition and Resettlement Plans for Tranche-2 of MFF: CAREC Corridor Development Investment Program.”**.
6. Bidders/Candidates are required to submit their bids strictly in accordance to Instructions to Bidders, Bidding Data Sheet of Bidding/Tender Document and NIT. Proposals must be prepared in hard book binding form to deny the possibility of addition or removal of page(s).
7. The technical proposals shall be opened on the same day at **1200 hours**, whereas the financial proposals of the technically qualified Consultant/Individual shall be opened after finalization of technical evaluation. Other details are provided in the RFP.
8. All the applicable Federal, Provincial & Local taxes must be considered while preparing the financial proposals. All these taxes are required to be built-in in the quoted rates and GST is to be mentioned separately.
9. The individual Consultant/Candidate providing unsubstantiated and/or incorrect information are liable to legal action and/or disqualification.
