NEED ANALYSIS (Why the procurement was necessary?)	(03) No bridges were constructed over (03) canals passing through Hyderabad Bypass Project, namely Canals, Phuleli-I, II & Akram Wah. The condition of bridges became deteriorated with passage of time, which prompted the need for construction of new additional bridges along the existing one, on both sides. The same was also endorsed by the Structural Expert of NHA. It was decided in principle to construct the bridges on both bounds i.e South Bound & North Bound and design of both sides was approved. However, due to insufficient funds, it was decided to construct the bridges in two phases; the bridges on South Bound side are already constructed, whereas three New Bridges shall be constructed on North Bound.

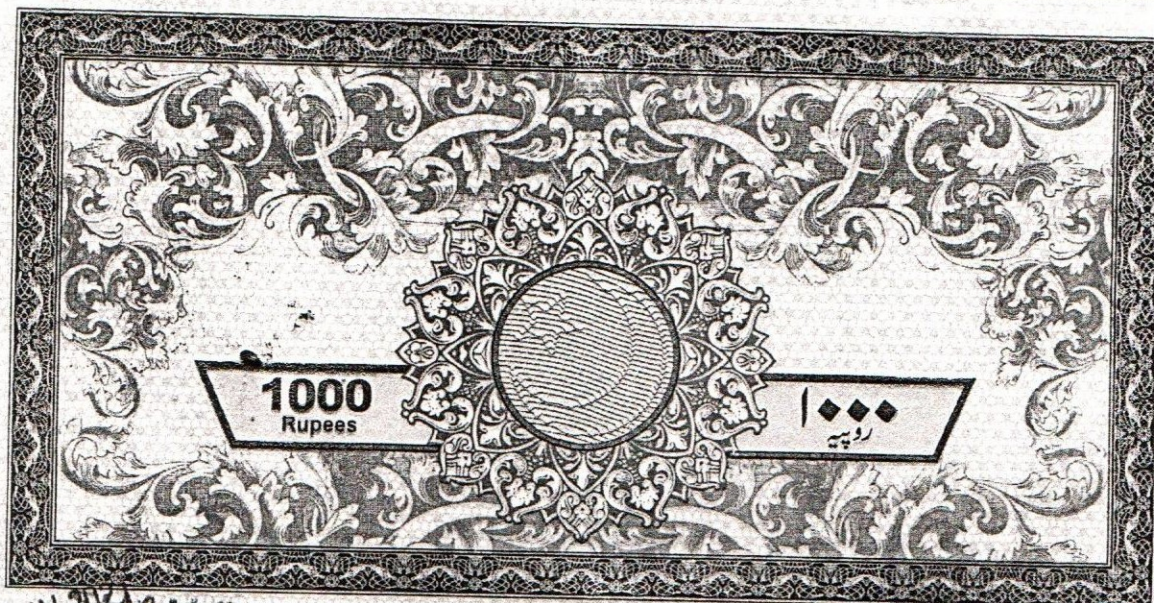

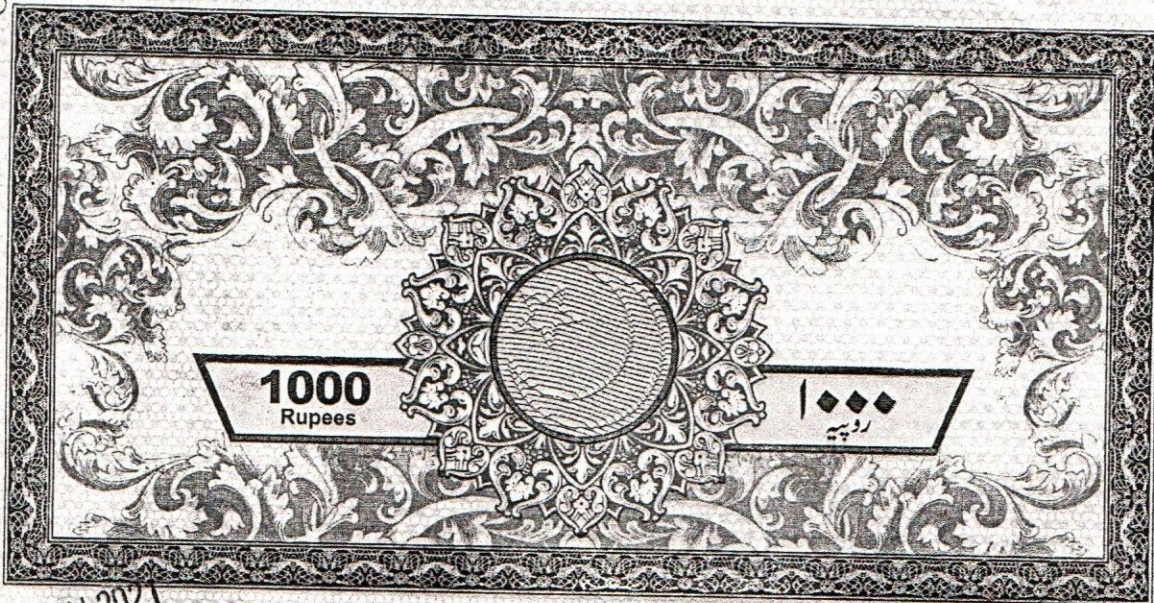
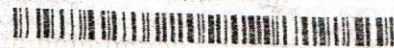
NOW this Agreement witnessed as follows:
