## e-Bidding System

### INVITATION FOR e-BIDS

1. The National Highway Authority (NHA) invites e-bids from Authorized Dealers/Resellers registered with Income Tax and Sales Tax Department and who are on Active Taxpayers list of Federal Board of Revenue, for the **Supply of IT Equipment (i.e. Laptops)**.
2. The bidding shall be done through NHA e-Bidding System [www.ebidding.nha.gov.pk](http://www.ebidding.nha.gov.pk). Bidders registered with Income Tax and Sales Tax Departments and who are on active Taxpayer List of Federal Board of Revenue, are required to create their "On-line User Account" for participation in the bidding. User Guide and video tutorial, illustrating the steps to create "On-line User Account", are available on homepage of NHA e-Bidding System website. Access to 'NHA e-Bidding System' for bidding, will be granted upon submission of pre-requisite documents as per guide line. e-Bid submitted, by using NHA e-bidding system, will only be considered, whereas other bids will be rejected. User Guide and video tutorial for Preparation & Submission of e-Bids are also available on homepage of NHA e-Bidding System website.
3. Complete set of Tender documents containing detailed terms & conditions, method of procurement (Single Stage - Two Envelope procedure), submission of e-Bids, Bid validity, opening of e-Bids, Evaluation Criteria, etc. will be available on NHA e-Bidding website on **10<sup>th</sup> November, 2021** for downloading free of cost. Prospective Bidders are also advised to follow the NHA website for updates of bidding schedule and addendum(s), if any.
4. The e-Bid must be prepared and submitted through NHA e-Bidding system in accordance with the instructions contained in the Tender Documents. Hard copy of e-Bid generated through NHA e-Bidding system, must reach at the address mentioned below on or before **29<sup>th</sup> November, 2021 at 1000 hours**. Technical e-Bids (submitted through NHA e-Bidding system) and envelope containing hard copy of Technical e-Bids, will be opened on the same day at **1030 hours**.
5. The bidders providing unsubstantiated and/or incorrect information shall be liable to disqualification and/or legal action.
