g.	International Master Program in Environmental Management and Sustainable Development
h.	Master of International Law and Chinese Law
i.	Master of Project Management

NHA’s Eligibility Criteria

a.	Minimum three years’ service in NHA.
b.	Must be a regular employee of NHA.
c.	The employee has not attended any other program abroad for duration of more than one month during last one year.
d.	His / her job is related to the scheduled program
e.	Not dealing with any special assignment
f.	Neat and clean service record & no departmental proceedings are pending or under process against him or area of his existing responsibility
g.	Recommendation by the Member In-charge

The addressees are requested to forward nomination of relevant Officers who are interested for the degree Program and meet the above mentioned eligibility conditions along-with duly filled/signed the following documents at the earliest but not later than **June 24, 2019**. Nomination received after due date or without any information or documents or without recommendation of the concerned Member will not be processed/entertained: -
