| d. | Have a university degree in discipline directly related to Logistics/Transport sectors and sufficient professional capacity                              |
| e. | Have a competent command of spoken and written English.  |
| f. | Be in good health, both physically and mentally.   |

| g. | Recommendation by the Member In-charge   |
| h. | Must not have been awarded any penalty/warning during last five years  |
