2. The Officers in BS-17 & above who fulfill the following eligibility criteria of NHA are eligible to apply: -

Eligibility Criteria of (Sponsors)

a.	Be the age between 25-40 for Master's degree and up to 45 years for Doctoral degree program as of April 1 st 2019
b.	Have obtained Master's degrees issued by a Japanese university for Doctoral degree program
c.	Have completed the undergraduate level (bachelor degree) of education for master's degree program
d.	Have not acquired Master's degree after studying abroad on a scholarship awarded by other foreign assistance
e.	Be CSS/Ex-Cadre Federal Government Officers of BPS-17 and above
f.	Have worked at least 3 years after entering public service at the time of application deadline
g.	Not currently availing another scholarship through other foreign assistance
h.	Have a competent command of spoken and written English.
i.	Be in good health, both physically and mentally

NHA's Eligibility Criteria

a.	Minimum three years' service in NHA.
b.	Must be a regular employee of NHA.
c.	The employee has not attended any other program abroad for duration of more than one month during last one year.
d.	His / her job is related to the scheduled program
e.	Not dealing with any special assignment
f.	Neat and clean service record & no departmental proceedings are pending or under process
g.	Recommendation by the Member In-charge
h.	Must not have been awarded any penalty/warning during last five years

3. Matter is circulated for information, dissemination and seeking suitable nominations/willingness of Officers **who fulfill the above mentioned criteria** at the earliest but not later than **December 21, 2018**.
