Note: Separate Technical Bids / Broachers for each contract alongwith 2% Bid Security / Earnest Money of the Engineers Estimated Cost in form of demand draft / pay order in favour of "NHA / RMA must be accompanied (**in original**) with each Technical Bids, in case of failures both the bids (Technical & Financial) could not be entertained. Further, **all the documents / papers in the Technical Bids must be firmly binded**, the loose bindings & spiral bindings will not be accepted.

- a. All prospective bidders are required to provide a Certificate from the authorized Converter of the original manufacturer of Highway Safety products, in the Technical Bid for Sr#03 (Highway Safety Work).
- b. Registration with Pakistan Engineering Council in Category C-4 or Above having specialization code CE-01 & CE-10 and CE-02(for Sr#01) for the year 2019.
- c. No Litigation Certificate on Judicial Stamp Paper.
- d. **Financial Competence:**
 - Financial Statement, Cash Flow Statement and Balance Sheet of Last (03) Years supported with Audit Report by Chartered Accountant.
 - Cash Flow and Average Annual Construction Turn Over as mentioned above is mandatory.
 - NTN Certificate.
 - [Working capital + Project specific lines of credit - current contract commitments] ≥25 Million.
 - Net worth at least 30 Million.
 - Income Tax Returns for last (03) years

- e. Contractor to provide list of equipment on Judicial Stamp Paper available with the firm which must include following:

If later on it was found that contractor does not own any equipment, NHA has the right to disqualify contractor from work and terminate the contract.

- f. List of Technical staff undertaking on Judicial Stamp Paper (that following staff will be available for execution of the works) also to be provided.

a) Highway / Structural Engineers	BE Civil with at least 05-years experience
b) Quantity Surveyor / Surveyor	DAE Civil with at least 05-years experience

- g. Documentation of similar value of works executed & completed must be provided. Letter of Award / Completion certificate and BOQ is not provided the experience shall not be counted which may lead to disqualification of the firm.

➤ **Requirements of Financial Bids / Tender Documents / Bill of Quantities .**

The bidder must have to provide the following document along with Financial Bids:

- Bill of Quantities alongwith full set of Tender Document complete in all respect (Signed & Stamped) and copy of 2% Earnest Money / payorder / Bid Security shall be attached with Financial bids.

Interested firms may obtain further information and collect bid documents from Office of Director (Maintenance) NHA Complex Airport Road Sukkur on written request by depositing a non refundable fee **Rs.1000/-** in form of demand draft / pay order in favour of "NHA / RMA Sukkur, during the office hours upto **27th March 2019 OR** may download the same from NHA website www.nha.gov.pk and submit to the mentioned address.

Prequalification documents along with sealed Financial bids complete in all respect and sealed in separate envelops should reach office of Director (Maintenance) NHA Sukkur on or before the deadline i.e. **28th March 2019 at 1130 Hours**. The prequalification documents will be opened in presence of contractors of the firms at **1200 Hours** in Conference Hall NHA Complex Airport Road Sukkur **on same day**.
5. Financial Bids of the firms will be sealed immediately by the Committee in the presence of the participating bidders / authorized representatives. After conducting Pre-qualification, the pre-qualified firms shall be informed in writing for opening of their financial bids while financial bids of disqualified firms shall be returned unopened.
6. The firms providing unsubstantiated and / or incorrect information are liable to legal action and disqualification.
7. The Bid Price includes all Government Taxes applicable during the period.
