Lowest Evaluated Bidder M/s HRK - MOC - SB (JV) (Joint Venture of M/s H.R.K. & Company - M/s Malik Abdul Qayyum Kakar & Company - M/s Shah their Builders) at evaluated bid price Rs.1,260,261,658/- (Rupees one billion, two hundred sixty million, two hundred sixty-one thousand, six hundred fifty-eight only), which is 18.03% below the Engineer's Estimate of Rs. 1,537,539,716/- (District Chitral) considering PPRA earlier letter No. 11(28)/ M&E/PPRA/2018/211 dated April 16. 2019 regarding acceptance of the bidder's voluntarily extended bid validity under PPRA Rule-26.

b. Package-II. The Executive Board allowed NHA to refer the case to Tender Acceptance Committee to reconsider the case by providing an opportunity of hearing to the authorized representative of the lowest bidder of the works for "Improvement & Widening of Chitral - Ayun - Bumborate Road (45.94 KMs), Package-II (29.46 KMS): including Bumburete to Kalash Valley (18.04 KMs) & Rumber to Kalash Valley (11.42 KMs)" in the light of order passed by Islamabad High Court, dated March 11, 2021 and PPRA earlier letter No. 11(28)/M&E/PPRA/2018/211 dated April 16, 2019 regarding acceptance of the bidder's voluntarily extended bid validity under PPRA Rule-26.
