Additional Agenda Item-I Improvement in Procurement Process

Decision

The NHA Executive Board approved that in future all procurement will be based on pre-qualification of contractors for the project as per PPRA Rule-15 and, thereafter, will request the pre-qualified bidders to submit their financial bids as per PPRA Rule-36(a) with following conditions:

- a. Contractor will submit Bid Security and Performance Security in the shape of Bank Guarantee from Scheduled Banks only. No Insurance Guarantee will be acceptable.
- b. Physical inspection of Machinery & Equipment and verification of Technical Staff by the GM concerned duly certified by Member concerned as per submitted bid documents during the pre-qualification process.
- c. The condition of past specific experience of similar work has been enhanced from 70% to 80% of Engineer's Estimates of the project to be procured.
- d. Contract will be awarded to construction companies which are technically & financially sound, have relevant experience and past performance credentials.
- e. Financial position will be determined from 3-years Certified Audit Reports using 1) Average Annual Construction Turnover, 2) Cash Flow, 3) Latest year's Working Capital & 4) Income Tax return.
- f. The Contractor must has valid registration with PEC.
- g. The Contractor has signed no Blacklisting Declaration and Integrity Pact. No Blacklisted firm will be allowed to participate in bidding process. The websites of PEC, PPRA and provincial procurement agencies shall be checked in this regard.
- h. Third Party Ground Validation of projects (worth more than Rs.2 billion) will be conducted at various stages of execution by a firm of international repute.

The Board directed to circulate the above instructions to all concerned for immediate implementation.
