1. National Highway Authority (Khyber Pakhtunkhwa Region) intends to offer Operations, Management & Maintenance Contracts (OM&MC) for **Three (03) No's. Bus Bays Pabbi (NB/SB), Akora Khattak (NB/SB) & Jehangira (NB/SB) and 80 Canopies at Pabbi Bazar on G.T Road**, on Advance Quarterly Net Guaranteed basis with 10% annual enhancement cumulatively to the private business entities (either sole proprietorship or partnership firm) through open/competitive bidding for a term of **Five (05) years**. Detail of bus bays is provided on the request for Proposal (RFP)/Bidding Document.
2. An interested bidder must possess minimum O-5 or above category of valid PEC License and must be a tax payer entity as per Federal Board of Revenue (FBR) record.
3. The request for proposal (RFP) documents (comprising detailed terms & Conditions, scope and requisite forms etc.) can be obtained from the office of Procurement Section NHA, Peshawar, during office hours by depositing of Rs. 2000/- (non-refundable) in form of pay order in favor of NHA, Road Maintenance Account. The bids shall be opened on same day in the presence of interested bidders or their authorized representatives at **1230 hours**. Bids will not be received after the stipulated time.
