1. The National Highway Authority intends to hire/ engage a Consultant (Engineering Organization/ Firm) for “Consultancy Services for Feasibility Study & Detailed Design for Construction of an Interchange at (M-3) Abdul Hakim Motorway at Essan, Sharaqpur District Sheikhupura, 20 Km from M-2”.
2. Proposals are invited from reputable Consultants (Engineering Organizations/ Firms) having valid Pakistan Engineering Council (PEC) registration certificate in relevant field alongwith enlistment on active Tax Payer List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP documents.

4. Pre-Proposal Conference will be held on **22<sup>nd</sup> September, 2022 at 1100 hours** in the office of General Manager (P&CA), National Highway Authority, Islamabad.
5. Procurement will be carried out by adopting “Single Stage Two Envelops” procedure. The Proposals complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on or before **10<sup>th</sup> October, 2022 at 1130 hours** in the office of General Manager (P&CA), NHA-HQ, 28-Mauve Area, G-9/1, Islamabad and be clearly marked “*Consultancy Services for Feasibility Study & Detailed Design for Construction of an Interchange at (M-3) Abdul Hakim Motorway at Essan, Sharaqpur District Sheikhupura, 20 Km from M-2*”.
