The General Manager (Maint) Punjab-North, National Highway Authority, Shahpur Interchange, Thokar Niazbeg, Multan Road, Lahore intends to auction the following surplus vehicles on **12.10.2022** at **12:00 hrs.** The vehicles alongwith documents can be inspected during working office hours.

2. The vehicles shall be auctioned through **Open Auction** on “**As is Where is Basis**” on the following conditions:

- a- Successful participants/bidder shall have to deposit **25%** of bid amount on the spot and remaining amount shall be deposited within a week time after the approval of competent authority.
- b- All taxes are applied as per prevailing laws of the Government of Pakistan.
- c- The vehicles shall be handed over to the successful participants/bidder after the transfer of ownership by NHA from the concerned ETO office. Transfer fee and other charges as per applicable law in force shall be borne by the successful participants/bidder.
- d- The successful bidder/Purchasers shall have to shift the vehicle at his own expense within ten working days from the date of letter of acceptance. Failing which ground rent @ 3% of the offer price shall be recovered up to a period of 30 days and thereafter the earnest money will be forfeited.
- e- The competent authority reserves the right to accept or reject any or all offers without assigning any reasons thereof and further reserves the right to withdraw any vehicle before or after the submission of offers.
- f- Pay order/demand draft amounting to **Rs.25,000/- (Rupees Twenty Five Thousand)** in favour of General Manager (Maint) Punjab-North NHA, Lahore for vehicles shall be deposited by the participants along with copy of valid CNIC as expression of interest/Token money, without depositing such PO/DD no person shall be allowed to participate in public auction.
- g- Vehicles shall be auctioned subject to availability of documents/willingness of bidder(s) to arrange the same at their own end.
- h- Remaining/outstanding Token Tax etc shall be paid by the successful bidder.
- i- In case of any dispute, the decision of auction committee shall be final and not challengeable in any Court of Law.
- j- Queries (if any) can be cleared at the spot thereafter no objection shall be entertained and decision of auction committee shall be final.
