### Agenda Item 1

PC-I for Rehabilitation and Reconstruction of N-5 from Moro to Ranipur Km 318-404 (NBC & SBC) and 32  $\times$  Damaged Bridges under ADB Flood Emergency Loan

#### **Decision**

The NHA Executive Board recommended the PC-I for "Rehabilitation and Reconstruction of N-5 from Moro to Ranipur Km 318 – 404 (NBC & SBC) and 32x damaged bridges under ADB Flood Emergency Loan" at a cost of Rs. 36,211,592,749/- (US\$ 164,598,149 @ 1US\$ = Rs.220) for approval of CDWP/ECNEC on the basis of umbrella PC-I prepared by NHA Planning Wing.

### Agenda Item 2

Consultancy Services for Feasibility Study and Detailed Design for D.I Khan Development Packages (542 Km)

### **Decision**

The NHA Executive Board approved the award of Contract for "Consultancy Services for Feasibility Study and Detailed Design for DI Khan Packages (542 KM)" to the most advantageous Consultant: M/s National Engineering Services Pakistan (Pvt.) Ltd., at rationalized cost of Rs.245,000,000/- (Rupees two hundred forty-five million only), which includes Salary Cost, Direct Non-Salary Cost and all type of applicable taxes including GST.

### Agenda Item 3

Updated PC-I for Construction of Dera Ghazi Khan Northern Bypass (20 KM)

#### **Decision**

The NHA Executive Board recommended the updated PC-I for Construction of D.G. Khan Northern Bypass (20 Km) at a cost of Rs.10.795 Billion for approval of CDWP/ECNEC on the basis of estimates prepared by the consultant and vetted by NHA Design Section.

## <u>Additional Agenda Item - I</u>

Allocation of NHA Land to NHMP on Rent for Establishment of Drivers Training School for NHMP Employees North Region Along Motorway (M-2) at Chakri Camp

#### **Decision**

The NHA Executive Board recommended, in principle, provision of 43 kanal land to NHMP for the purpose of construction of building for establishment of Drivers Training School for NHMP employees North Region along Motorway (M-2) at Chakri Camp on rental basis on following similar terms and conditions already approved by the Board in its 352nd meeting, for approval by the National Highway Council:

### Terms & Conditions

- a. Land be provided by NHA to NHMP for establishment of Drivers Training School for NHMP employees North Region along motorway (M-2) at Chakri camp on rent for a period of 20 years:
- b. Rent amount for such land shall be equal to cost incurred on the acquisition of that land by NHA and the same shall be paid to NHA by NHMP in 20 equal annual installments.
- c. The land shall only be used for the purpose of construction of building for establishment of Drivers Training School NHMP. In case of any change of use other than construction of Office buildings, the land shall stand automatically reverted to NHA.
- d. The Highway Safety, including construction of acceleration/deceleration lanes and provision of mechanism to prevent road hazards, shall be sole responsibility of NHMP.
- e. Design of facility shall be submitted to NHA and shall be vetted by the concerned section of NHA.

f. NHMP shall ensure clearance of all financial liabilities like utility charges or any other cost incurred during establishment and functioning of office buildings.

The Board also referred the case to NHA Executive Board Audit Committee to examine and suggest way forward regarding outstanding amount towards NHMP to the tune of more than Rs. 20.4 Billion.
