- 3. Non-compliance of said instructions tantamount to misconduct in terms of Government Servant (Conduct) Ruels-1995, cognizable under the NHA Efficiency & Discipline Rules, 1995. The PERs/ACRs and Declaration of Assets are also required to be placed before the Departmental Promotion Committees (DPCs) and grant of time scale promotions. Missing PERs/ACRs and Assets Declaration effect promotion process.
- 4. The addressees are requested to submit their own PERs and Declaration of Income and Assets (if any) and also ensure /direct submission of PERs/ACRs

and Assets Declaration of all officers/officials under their jurisdiction to Admn Wing (Confidential Section) NHA, HQ duly completed in all respects immediately.
